## **Standing Committee Announces Schedule of Televised Hearings**

**IQALUIT, Nunavut (April 8, 2024)** - The Legislative Assembly's Standing Committee on Oversight of Government Operations and Public Accounts will hold televised hearings from April 19-20, 2024, on the most recent annual report of the Information and Privacy Commissioner of Nunavut and from April 22-23, 2024, on the most recent annual reports of the Representative for Children and Youth.

Senior officials from the Government of Nunavut will also appear as witnesses at the televised hearings.

“Our televised hearings will provide an opportunity for Members of the Legislative Assembly to consider the extent to which the Government of Nunavut is taking action to address recommendations made by these independent officers and the standing committee itself,” said Committee Chairperson George Hickes, MLA for Iqaluit-Tasiluk.
