Item 1: Opening Prayer

Clerk (Mr. Quirke): Good afternoon. Before we proceed, I will call on Looee Mike to lead us in a prayer. Reverend Looee Mike, please.

>>Prayer

Clerk: Thank you. It is my duty to inform the members that the Commissioner of Nunavut will not enter the Chamber until members have appointed the Speaker. Is there a motion to appoint the Speaker? Member for Netsilik.

Item 2: Election of Speaker

Motion: Appointment of Speaker

Ms. Ugyuk (interpretation): Thank you, Mr. Clerk. I move, seconded by the Hon. Member for Iqaluit-Niaqunnguu, that George Qulaut, Member for Amittuq, do take the Chair of this House as Speaker. Thank you, Mr. Chairman. **Clerk**: The motion is in order. All those in favour. Opposed. The motion is carried. May I ask the mover and the seconder of the motion to escort the Speaker to the Chair.

Speaker (Mr. George Qulaut) (interpretation): Thank you. That was too much. Thank you. I call upon the Sergeant-at-Arms to raise the mace.

Thank you. As Speaker of the Legislative Assembly of Nunavut, I am very pleased to welcome our elders, distinguished guests and visitors to the House for the first sitting of the Fourth Legislative Assembly.

(interpretation ends) I would like to express my appreciation to all members for the trust and confidence that you have placed in me by selecting me to serve as your Speaker.

I would also like to take this opportunity to publicly thank my constituents in Igloolik and Hall Beach for their support during the recent election.

As Speaker, I am committed to upholding the rights and privileges of this institution and its members.

All members can be assured that I will approach my responsibilities in a manner that is consistent with the office's obligation to demonstrate fairness and impartiality.

Earlier today, all Members of this House took their oaths of allegiance and office.

I look forward to working with all of my colleagues during our term of office on behalf of our territory and residents.

(interpretation) I also wish to express my appreciation and love for my wife, Patricia, our sons, John Paul Aapak Evaluarjuk and Silas Qulaut, and our children and grandchildren who are not in the Chamber. Their support is my strength.

(interpretation ends) Finally, I am very pleased to take this opportunity to say a few words about our Chamber's new qamutiik that has been generously donated to the Legislative Assembly by the Tukisigiarvik Community Wellness Centre in Iqaluit.

This example of a traditional qamutiik was made by Lucassie Kootoo, Nash Sagiatook, Jimi Davidee, Mosesee Atagoyuk, and Noah Alookie.

I would note that the sliders on the bottom of the qamutiik are made from baleen harvested from the bowhead whale that was taken by Iqaluit hunters in August 2011. On behalf of all members, I express our appreciation for this beautiful piece.

We will now proceed with the orders of the day.

At this time, I will ask the Clerk to determine if Her Honour the Commissioner of Nunavut is prepared to enter the Chamber to deliver the Opening Address.

Opening Address of the Commissioner of Nunavut

Commissioner Edna Elias

(interpretation): Please be seated. We're back here again. Everybody is here, even though we have very bad weather out there. Mr. Speaker, elders, Premier, ministers, members, and Nunavummiut in the visitors' gallery and at home, welcome to the First Session of the Fourth Legislative Assembly of Nunavut.

First, please allow me to congratulate Speaker Qulaut on your election as Speaker. As Speaker you are the guardian of the centre of democratic government in Nunavut. This Assembly is where 22 Nunavummiut, chosen by their fellow citizens, come together to make law, approve budgets, and hold the government accountable to the benefit of all Nunavut.

Congratulations to all of the members. You have earned the trust and confidence of your constituents. They now rely on you to act wisely and prudently on their behalf.

Congratulations to Premier Taptuna and the members of the new cabinet. You are the Fourth Executive Council of Nunavut. Nunavut relies on your foresight and leadership to increase opportunities for this generation and build a strong foundation for the future generations.

I trust that this Assembly will always be guided by Inuit societal values. In particular, please keep *Aajiiqatigiinniq* – decision-making through discussion and consensus – foremost in your minds. Through discussion and consensus, Inuit have exercised governance over themselves for centuries. Let it be your guide through the following years.

The development and approval of the fourth mandate will require much discussion and consensus. I encourage you to think of the future when doing so; a future of self-reliance, a future of Inuit retaining control over their lands and themselves. It is very appropriate that in our 15th year as a territory, we begin taking strong steps forward to that future. It is clear from the October Throne Speech that the Government of Canada is ready to begin negotiating devolution with the Government of Nunavut and Nunavut Tunngavik Incorporated. We all look forward to the outcome.

For the following years, you have the task to keep building Nunavut. In the next sessions, the government will bring forward the capital and operating budgets. Please use our resources prudently. The government will also begin to bring forward new legislation and amendments to existing legislation. Please make wise law.

As Members of the Assembly, each of you bears the responsibility of representing your constituents and ensuring that the government serves the best interests of all Nunavummiut. I am confident that you will serve the people of Nunavut to the best of your abilities and that you will contribute to building a stronger Nunavut. I extend my best wishes to all of you.

I now declare open the First Session of the Fourth Legislative Assembly of Nunavut. Thank you.

Member for Tununiq, Joe Enook.

Item 4: Members' Statements

Member's Statement 001 – 4(1): Reflections on Being Re-elected to Represent Tununiq

Mr. Enook (interpretation): Thank you, Mr. Speaker. I rise today to express my deep gratitude to the people of Pond Inlet for the trust and confidence that they have again placed in me to represent them in their Legislative Assembly.

Mr. Speaker, as you will appreciate, it is essential at times like this that we pay tribute to our families and loved ones.

I have been blessed with the unwavering support of my wife, Mary Kilabuk, and our children and my family, and I thank them from the bottom of my heart.

Mr. Speaker, I would also like to take this opportunity to formally congratulate you on your selection as our Speaker. I very much look forward to working closely with you during our term of office together.

Mr. Speaker, a little over two years ago, I had the opportunity to make my first Member's Statement in this House. Since that time, I have listened closely to the concerns and issues raised with me by the residents of Pond Inlet.

(interpretation ends) Mr. Speaker, I am very pleased to note that voter turnout in Tununiq increased significantly at the recent general election. Over 500 residents of the community exercised their right to choose their elected representative.

Mr. Speaker, this high level of participation clearly demonstrates that Nunavummiut are engaged and committed to ensuring that their institutions of governance are responsive and accountable.

Mr. Speaker, although it also shows that our constituents have confidence in the ability of public institutions and representatives to achieve change and progress, we must be mindful of our responsibility to live up to this confidence.

Mr. Speaker, I ask for unanimous consent to conclude my statement today. (interpretation) Thank you, Mr. Speaker.

Speaker: The member is seeking unanimous consent to conclude his statement. Are there any nays? There are no nays. You may proceed.

Mr. Enook (interpretation): Thank you, Mr. Speaker. Thank you, my colleagues.

Mr. Speaker, when I first took my seat in the Legislative Assembly, I made a solemn promise to serve as a forceful and vocal advocate for the needs and goals of the constituency. Mr. Speaker, I renew that promise today.

Mr. Speaker, during the recent election campaign, I heard a number of very clear messages from my constituents as to what they expect the new government to achieve.

The need for modern marine infrastructure in Pond Inlet continues to be critical. As my colleagues who sat with me in the previous Legislative Assembly will recall, this has been an issue that I have raised in the House at every possible opportunity. Mr. Speaker, I can assure whoever will be serving as our new Minister of Economic Development that he or she can look forward to answering some questions from me on this issue at our first full sitting.

Mr. Speaker, as you know, these are exciting times for the residents of Pond Inlet and its neighbouring communities.

Two years ago, my first Member's Statement in this House addressed the issues of economic growth and selfsufficiency.

(interpretation ends) Mr. Speaker, the recent signing of the Mary River Project Inuit Impact and Benefit Agreement between the Qikiqtani Inuit Association and Baffinland Iron Mines Corporation is another major step forward towards achieving these goals.

Mr. Speaker, I look forward to continuing the important work of ensuring that our territorial government takes complementary and decisive actions in this area.

The formal designation of Pond Inlet as the hub airport for the High Arctic is one such action, as is the negotiation and signing of a formal development partnership agreement between the GN and Baffinland.

(interpretation) Mr. Speaker, although there are many other issues that need to be addressed during our term of office, I will conclude my Member's Statement today by reflecting on the importance of achieving change and progress.

Mr. Speaker, this does not mean that we will always agree with each another on every single issue that comes before the House. Indeed, a level of vigorous and respectful debate should be welcomed as a healthy and important component of a transparent and accountable legislature.

Mr. Speaker, I look forward to working with both returning and newly elected Members of this House for the good of our territory and its wonderful people. Thank you, Mr. Speaker.

Member's Statement 002 – 4(1): Reflections on Being Elected to Represent Baker Lake

Mr. Mikkungwak (interpretation): Thank you, Mr. Speaker. First of all, I send my thoughts to the people who are doing search and rescue in Baker Lake at this time.

Mr. Speaker, I will begin by offering praise to our Lord and Saviour.

(interpretation ends) Mr. Speaker, I rise today to thank the people of Baker Lake for allowing me the privilege of serving them in the Legislative Assembly.

(interpretation) Mr. Speaker, there are a number of people whom I wish to take this opportunity to acknowledge. (interpretation ends) First and foremost is my family, whose support and strength I rely on every day.

I am blessed that my wife, my mother, and other close relatives have been able to join us for this special occasion.

Mr. Speaker, the recent election campaign was an excellent experience. I want to congratulate my fellow candidate, Karen, for also putting her name forward.

Mr. Speaker, I could not have been successful in the election without the hard work of my campaign team. I want to pay special tribute to my campaign manager, Richard Aksawnee, and my financial agent, Robert Seeteenak.

Mr. Speaker, over 600 residents of Baker Lake voted in the recent general election. I want to thank each and every one of them.

Mr. Speaker, I am committed to working closely with all Members of the Legislative Assembly during our term.

(interpretation) As you know, Baker Lake has been experiencing unprecedented economic growth in recent years as a result of the booming mining sector in our region.

As we move forward, I will be consulting closely with municipal leaders and ordinary residents on the issues that affect our families.

Mr. Speaker, (interpretation ends) such issues as improving health care, fostering economic diversification, and strengthening education require our attention, our energy, and our commitment. Member's Statement 004 – 4(1): Reflections on Being Elected to Represent Aivilik

Mr. Mapsalak (interpretation): Thank you, Mr. Speaker. First of all, I would like to thank my wife because I wouldn't be here if she wasn't here, but she couldn't make it to the Assembly.

I would also like to thank the people who assisted me from Repulse Bay and Louie Bruce from Coral Harbour. I appreciate and thank all the people of Repulse Bay and Coral Harbour.

Mr. Speaker, we promised to represent our constituents and our responsibility and what I'm going to do for my people won't be coming from me, but from my constituents, any questions that I may pose.

I am very pleased that I am able to come back to the Legislative Assembly. I was a previous MLA in 2008. I also appreciated that.

Last year, on November 5, my wife and I fell in water. We got into a bad accident. If there was no search and rescue, we wouldn't be here today. I appreciate that very much. At that time, the search and rescue personnel who were involved were John Tinashlu, his son Josie Tinashlu, his other son John Tinashlu, his in-law, Johnny Tagornak, Stephan Siusangnark, and Darrel Siusangnark. Mr. Speaker, I thank these people very much. If it wasn't for them, I wouldn't be standing here with you.

I know that we have some responsibilities and some work to do.

Mr. Speaker, I would like to ask for unanimous consent to conclude my statement. Thank you, Mr. Speaker.

Mr. Mapsalak (interpretation): Thank you, Mr. Speaker.

questions. I know that we won't agree with the government all the time. We have a big responsibility and work ahead of us. People in the communities need and want different things. As MLA for four years, I will try to work and represent the people. Thank you, Mr. Speaker.

Member's Statement 005 – 4(1): Reflections on Being Elected to Represent Arviat South

Mr. Savikataaq (interpretation): Thank you, Mr. Speaker. I rise today to thank the residents of Arviat South who have placed their trust and confidence in me to represent them in the Legislative Assembly.

(interpretation ends) Mr. Speaker, I would like to take this opportunity to formally join with my colleagues in congratulating you for having been elected to serve as our Speaker.

Mr. Speaker, I would not be here today with you and all of my colleagues if it were not for the strong support that I have received from my family over the past five years. Mr. Speaker, I want to again pay tribute to my family for their support, their love, and, most importantly, their patience over the past five years.

Mr. Speaker, five years ago, I rose in this House for the first time to express my appreciation to the community for their confidence in me, and to promise that I would represent the constituency to the best of my ability. Mr. Speaker, I make the same commitment today. Mr. Speaker, I will continue to voice the concerns of the community regarding such issues as the high cost of living, the need for new infrastructure and housing, the need for effective programs and services, the need to support our hunters, the need to protect the unique environment of Hudson Bay, and the need for economic development.

At the same time, I also look forward to working with members on both sides of the House on issues that affect all of Nunavut. Mr. Speaker, I would like to finish today by noting that it's also no secret that hockey plays a big role in my family's life. Although I am not going to risk provoking this Assembly's first point of order by saying which team we support, I do want to say that my years of coaching youth hockey have reinforced my belief that we're only going to succeed if we play as a team. Every time there are dignitaries coming into Taloyoak, please provide support. I appreciate the people who come and visit our communities for teaching me to be compassionate.

I know that we have a hard four years ahead of us, and I want to work closely with you on behalf of the children, youth, women, and elders. I say "good afternoon." I'm sure that we will be seeing each other. Thank you, Mr. Speaker.

Mr. Speaker, I would like to extend my appreciation to the people who voted in the constituency of Aggu and to my supporters.

I would like to thank my financial agent, Elijah Evaluardjuk. I'm sure you know him because his father, Mark Evaluardjuk, was one of our first Members of the Legislative Assembly of the NWT.

I would also like to thank the previous Member for Amittuq, Louis Tapardjuk. Although he is no longer a Member of the Legislative Assembly, his wife, Lucie, my sister, is here and I'm very proud of him serving us. I'm sure we remember that as Members of the Legislative Assembly, he worked very hard on Inuit societal values. I would also like to thank my wife, Elisapee, and my family, Akuttuugaq, and all our children, who have been very supportive in our community. Even though I travel and stay away from home for long periods, they never change their compassion for me. I'm sure it's likewise with the rest of the members.

I would like to congratulate all Members of the Fourth Legislative Assembly. We bring in different viewpoints, so we will have to work closely together.

First of all, I would like to congratulate you for being selected as the Speaker and committing yourself. You were the only person who was nominated. You tried to nominate me, but I will not think of becoming a Speaker again after watching you being dragged and carried to the Chair.

I thank each and every one of you who are here. First of all, I would like to congratulate our new Premier, his wife and family. I'm sure that you will guide us during our deliberations.

I would also like to extend my gratitude to my family, my son, my daughter, my wife, and my sister who are here with me today, especially my wife. We support each other. She is the reverend in Pangnirtung. She also goes to different communities. I give her my support fully. She takes care of the newborns through to the funeral stage. Therefore, we need to support them.

I would like to thank my wife very much for opening the meeting with a prayer. I would also like to state that she's the first Inuk woman who was ordained as a reverend in 1994 for the Anglican Diocese.

I would also like to thank all of my children. I would like to thank the seniors of Pangnirtung for encouraging me during my campaign. I know that sometimes it gets a bit disappointing when you're campaigning. Therefore, I would like to thank the seniors of Pangnirtung, especially our elders, Inuusiq Nashalik of Pangnirtung, who is the eldest of our community, and Sila Metuq, my aunt, who is the second oldest.

When I was campaigning....

I seek unanimous consent to conclude my statement. Thank you.

Speaker (interpretation): The member is seeking unanimous consent to conclude his statement. Are there any nays? There are no nays. You may proceed.

Mr. Mike (interpretation): Thank you, Mr. Speaker.

I need to express my gratitude to my financial agent, Charlie Komoartok, and also my campaign manager, Danny Kuluguqtuq.

I would also like to thank the other candidates, Hezekiah Oshutapik, Sakiasie Sowdluapik, and Harry Dialla. I would like to thank Hezekiah and his wife. He was a Member of the Legislative Assembly for Pangnirtung. Thank you very much.

During the general election, the voter turnout in Pangnirtung was 80 percent. I would like to thank the people of Pangnirtung very much for placing their trust in me to represent them and to be their voice in this new government.

I would also like to thank the leaders in our community and my relatives. Late Ipeelee Kilabuk, my uncle, was a Member of the Legislative Assembly of the NWT. My sister, Rebecca Mike, was also a Member of the Legislative Assembly. My cousin Peter Kilabuk was also a Member of this House. I would like to extend my gratitude to the people and to the previous MLAs for paving the way.

I would especially like to extend my gratitude to the Auyuittuq National Park, the Qikiqtani parks, establishing the tourism information centre in Pangnirtung, and also to the people who were managing the fish plant. We have a fish plant in our community and the fishermen keep the fish plant open. Artists sell their carvings and handicrafts to Uqqurmiut and include Uqqurmiut for the handicrafts and for developing those.

For fisheries, we have a quota of 500 metric tonnes for inshore fisheries. It's a little over 1 million lbs. The fishermen of Pangnirtung have worked very hard and I acknowledge them. They paved the way. Everything is now comfortable and everything has been set.

The docking facility in our community is operating very well. It was very difficult to obtain the docking facility and hope that you will get your docking facility in your community not as long as Pangnirtung waited. We waited for over 25 years.

Again, I would also like to thank the people who caught the bowhead whale in Pangnirtung this summer. I would like to thank all the hunters who participated in that harvest. It was a very successful hunt for the captain, Simeonie Keenainak, and his crew. My two sons participated in the bowhead whale hunt. My 12-year-old son was in the captain's boat. This is something that I'm very proud of, so I would like to acknowledge the hunters.

Today, we have a lot of challenges. With limited financial resources within the government, shortage of housing, and especially having to find additional funds to fund daycares, new housing, roads, off-roads in the hamlets, fisheries development, and to provide more financial support for our hunters and fishers. It's very obvious that we have a lot of challenges ahead of us.

With the Qikiqtani Truth Commission completed and the report being made available to the public, we have to do something about it so that we can reconcile. It's going to be a better road for all of us to start further development. My colleague, Mr. Quassa, stated that Articles 5, 23, 24, and 32 of the land claims agreement will have to be implemented because it was agreed to by the Inuit.

I look forward to our endeavours. I will work very hard with my colleagues and I will want to truly represent my constituents in the House with all my abilities. Also to the cabinet and regular members, I would like to have a very close working relationship with you so that we can pave a better life for the people of Nunavut.

Lastly, I would like to thank George, who nominated me to the cabinet. Thank you.
