### **INTRODUCTION & METHODOLOGY**

#### **Introduction**

This annual report aims to support the integrity and transparency of Nunavut Housing Corporation's contracting practices. This aligns with the broader requirements for Canadian federal and provincial governments to prepare contracting and procurement activity reports, which are mandated to ensure fairness, openness, and accountability in public procurement processes. These reports are essential for maintaining public trust and ensuring that government procurement activities are conducted in a manner that achieves value for money and adheres to legal and policy frameworks.

For the Government of Nunavut, these reporting practices are particularly relevant due to the territory's unique socio-economic and geographic challenges. The Government of Nunavut's commitment to transparency and accountability in procurement is crucial for fostering local economic development and ensuring that resources are used effectively to benefit Nunavummiut. Additionally, these reports help measure progress toward achieving the objectives outlined in Article 24 of the Nunavut Agreement, which emphasizes the importance of supporting Inuit participation in the economy.

#### **Methodology**

This report is structured according to the contracting procedures established by the Government of Nunavut (GN) and utilizes data from the Nunavut Housing Corporation's (NHC) databases. It includes statistical information and detailed accounts of the NHC's contracts, as well as operating and maintenance expenditures for the fiscal year 2023-2024.

This report is generated based on data logged by the NHC Procurement Department throughout the year. The Procurement Department records all contracting activities, ensuring that each transaction is documented. At the end of the fiscal year, this data undergoes a thorough verification process. It is cross-referenced and validated against the financial data generated by the NHC Finance Department during the fiscal year-end closeout. This verification process

ensures that the data presented in this report is both comprehensive and accurate, reflecting the true state of the NHC's contracting and procurement activities.

By adhering to this process, the NHC ensures that the report not only meets the standards set by the Government of Nunavut but also upholds the principles of transparency and accountability.

### TERMS

**Goods:** In this report, “Goods” means contracts for the purchased goods primarily entered into by Nunavut Housing Corporation using a purchase order.

**Invitational Tenders:** those tenders for which tender documents are sent to contractors or suppliers specifically selected to submit tenders.

**Public tender:** are those tenders which are publicly advertised.

**Sole source:** is best defined by setting out the criteria. The Government of Nunavut contract regulations, under the Financial Administration Act, allow sole sourcing of contracts where a contracting authority believes, on reasonable grounds, that one of the following is applicable:

- a) The goods, services, or construction are urgently required, and delay would be injurious to the public interest; or
- b) Only one party is available and capable of performing the contract; or
- c) The contract is an architectural or engineering contract that will not exceed \$25,000; or
- d) Or any other type of contract that will not exceed \$5,000 in value.

**Request for Proposal (RFP):** has been defined as follows, “when the government knows what the end result should be, but not necessarily how best to achieve it; therefore, the government seeks proposals on methods, ability, and price. Government can thereby negotiate the best method to achieve the best value.”

**Tender:** A tender may be obtained by public advertisement or private invitation. It should be noted that, generally, the value and type of contract will determine the type of tendering to be used.

### REPORT OVERVIEW

This report provides a comprehensive analysis of the distribution of contracts awarded by the Nunavut Housing Corporation (NHC), categorized by their NNI registration status. The NNI registration IDs are defined as follows:

- **INUIT:** Inuit-owned businesses registered with NTI
- **NUNAVUT:** Businesses registered with the Government of Nunavut
- **OTHER:** Businesses that do not fall into the above categories

In the supporting data sheets, companies that are registered with both NTI and NNI (NTI/NNI) are classified as “Inuit” in the summary information. Companies registered only with NNI are classified as “Nunavut,” while those without NTI or NNI registration are grouped under “Other.”

The detailed contract information is organized into two main sections: Section A and Section B.

- **Section A** focuses on Major Construction projects, as defined by the Government of Nunavut’s Contracting Procedures Manual. This section includes contracts with a value of \$25,000 or greater and provides summarized tables of these contracting activities.
- **Section B** reviews Operating and Maintenance (O&M) Expenditures, which include categories such as Professional Services, Air Charters, Maintenance Expenses, Goods, Leases, and Sole Source Contracts. This section includes contracts with a value of \$5,000 or more and provides summarized tables of these expenditures.

The final section of the report, **Appendix A**, contains the detailed data that the summary tables in Sections A and B are based on. This appendix ensures transparency and allows for a deeper understanding of the NHC’s contracting and procurement activities.

**SUMMARY OF SECTION A—MAJOR CONSTRUCTION CONTRACTS**

This section contains all major construction contracts awarded for \$25,000 or higher during the fiscal year 2023 – 2024. It contains tables and figures to summarize contracts related to Major Construction broken down by Procurement Method use to secure a vendor for the construction and by NNI Status Classification.




Figure 1 - Major Construction by Procurement Method




Figure 2 - Major Construction by NNI Classification








Figure 5 - Air Charters by Procurement Method




Figure 6 - Air Charters by NNI Classification




Figure 7 - Maintenance Expenses by Procurement Method




Figure 8 - Maintenance Expenses by NNI Classification




Figure 9 - Goods by Procurement Method




Figure 10 - Goods by NNI Classification

## Leases

This section provides information on leases held by the NHC used for public and staff housing.

In 2023-2024, new leases were primarily procured through Public Request for Proposals (PRFP). Where possible, NHC opted to renew most leases under the same vendors, as the units were already occupied by NHC public housing or staff housing tenants. Failing to renew the leases would cause significant disruption to operations.

Leases acquired through Memoranda of Understanding (MOUs) are in respect of units acquired on behalf of departments of the Government of Nunavut. All new and all renewed leases are for a period between one and five years.




Figure 11 - Leasing by Procurement Method




Figure 12 - Leasing by NNI Classification

### Sole Sourcing

Sole Source contracting practices are monitored closely. NHC believes it can get the best value for money through competitive bidding processes. However, there are limited instances where the GN's contracting procedures permit awarding contracts without competition. Listed below are the acceptable conditions for awarding contracts without competition:

1. The goods, services or construction are urgently required, and delay would be harmful to the public interest.
2. Only one party is available and capable of performing the contract.
3. The contract is an architectural or engineering contract that will not exceed \$25,000 in value or is any other type of contract that will not exceed \$5,000 in value.

**Goods:** Most Sole Source contracts are for specialized software and computer services.

**Leases:** There are instances when NHC must enter into lease agreements via sole source due to the shortage of available rental units.

**Services:** The increase in service contracts comes primarily from NHC's subscription to an online training platform for staff development.

**Maintenance:** Most Sole Source contracts were for community emergencies or specialized services.
