### **INTRODUCTION & METHODOLOGY**

#### **Introduction**

This annual report aims to support the integrity and transparency of Nunavut Housing Corporation's contracting practices. This aligns with broader requirements for Canadian federal and provincial governments to prepare reports on contracting and procurement activities, which are mandated to ensure fairness, openness, and accountability in public procurement processes. These reports are vital for maintaining public trust and ensuring that government procurement activities are conducted in a way that delivers value for money and complies with legal and policy frameworks.

For the Government of Nunavut, these reporting practices are especially important due to the territory's unique social, economic, and geographic challenges. The Government of Nunavut's dedication to transparency and accountability in procurement is vital for fostering local economic growth and ensuring that resources are used efficiently to benefit Nunavummiut. Furthermore, these reports assist in tracking progress toward the goals outlined in Article 24 of the Nunavut Agreement, which highlights the importance of supporting Inuit participation in the economy.

#### **Methodology**

This report is structured in accordance with the Government of Nunavut's (GN) Contracting Procedures Manual and is based on data collected and maintained by the Nunavut Housing Corporation (NHC). It provides a comprehensive overview of contracting, procurement, and leasing activities for the fiscal year 2024–2025, including both statistical summaries and detailed listings.

Throughout the fiscal year, the NHC Procurement Department systematically records all contracting activities. Each transaction is logged with key details such as vendor, contract type, selection method, and value. This data is not only used for operational tracking but also forms the foundation of this report.

At the end of the fiscal year, the recorded procurement data undergoes a rigorous verification process. It is cross-referenced against financial records maintained by the NHC Finance Department during the year-end closeout. This dual validation ensures that the information presented is both accurate and complete, reflecting the true scope of NHC's procurement and contracting activities.

The report also categorizes contracts by procurement method, NNI/Inuit business status, and contract type, in alignment with GN reporting standards. Contracts are included based on established thresholds:

- **Major Construction Contracts:** \$25,000 and above
- **Operations and Maintenance (O&M) Contracts:** \$5,000 and above

This methodology ensures that the report meets the GN's standards for transparency, accountability, and value-for-money. It also supports the Government's obligations under Article 24 of the Nunavut Agreement, by enabling the tracking of Inuit participation in the territorial economy.

By adhering to this structured and validated approach, the NHC reinforces its commitment to good governance, responsible stewardship of public funds, and support for Inuit and Nunavut-based businesses.

### TERMS

**Goods:** In this report, “Goods” means contracts for the purchased goods primarily entered by Nunavut Housing Corporation using a purchase order.

**Invitational Tenders:** those tenders for which tender documents are sent to contractors or suppliers specifically selected to submit tenders.

**Public tender:** are those tenders which are publicly advertised.

**Sole source:** is best defined by setting out the criteria. The Government of Nunavut contract regulations, under the Financial Administration Act, allow sole sourcing of contracts where a contracting authority believes, on reasonable grounds, that one of the following is applicable:

- a) The goods, services, or construction are urgently required, and the delay would be injurious to the public interest; or
- b) Only one party is available and capable of performing the contract; or
- c) The contract is an architectural or engineering contract that will not exceed \$25,000; or
- d) Or any other type of contract that will not exceed \$5,000 in value.

**Request for Proposal (RFP):** has been defined as follows, “when the government knows what the end result should be, but not necessarily how best to achieve it; therefore, the government seeks proposals on methods, ability, and price. Government can thereby negotiate the best method to achieve the best value.”

**Tender:** A tender may be obtained by public advertisement or private invitation. It should be noted that, generally, the value and type of contract will determine the type of tendering to be used.

### Report Overview

This report presents a comprehensive analysis of the contracting, procurement, and leasing activities undertaken by the Nunavut Housing Corporation (NHC) during the fiscal year 2024–2025. The analysis is organized to reflect the distribution of contracts based on NNI registration status, procurement method, and contract type.

### NNI Classification

Contracts are categorized according to the Nunavummi Nangminiqagtunik Ikajuuti (NNI) Policy registration status of the awarded vendors:

- INUIT: Inuit-owned businesses registered with Nunavut Tunngavik Incorporated (NTI).
- NUNAVUT: Businesses registered with the Government of Nunavut (GN) under the NNI program.
- OTHER: Businesses not registered with either NTI or GN.

For reporting purposes:

- Vendors registered with both NTI and NNI (NTI/NNI) are classified as Inuit.
- Vendors registered only with NNI are classified as Nunavut.
- Vendors without either registration are grouped under Other.

### Report Structure

The report is divided into two primary sections, followed by a detailed appendix:

#### **Section A: Major Construction Contracts**

Includes contracts valued at \$25,000 or more.

Focuses on large-scale construction projects as defined by the GN's Contracting Procedures Manual.

Summarized by procurement method and NNI classification.

### **Section B: Operations and Maintenance (O&M) Expenditures**

Includes contracts valued at \$5,000 or more.

It covers a broad range of categories including:

- **Professional Services**
- **Air Charters**
- **Maintenance**
- **Goods**
- **Leases**
- **Sole Source Contracts**

Summarized by procurement method and NNI classification.

### **Appendix A**

Contains the full detailed listings of all contracts referenced in Sections A and B.

Provides transparency and enables deeper analysis of NHC's procurement activities.

This structure ensures that the report is both accessible and informative, supporting internal review, public accountability, and strategic planning aligned with GN policies and the Nunavut Agreement.

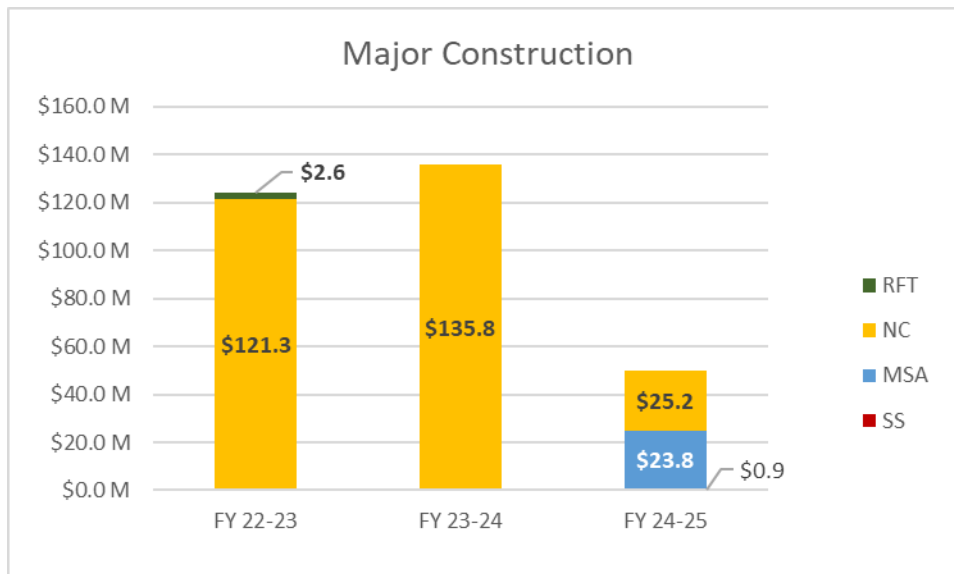

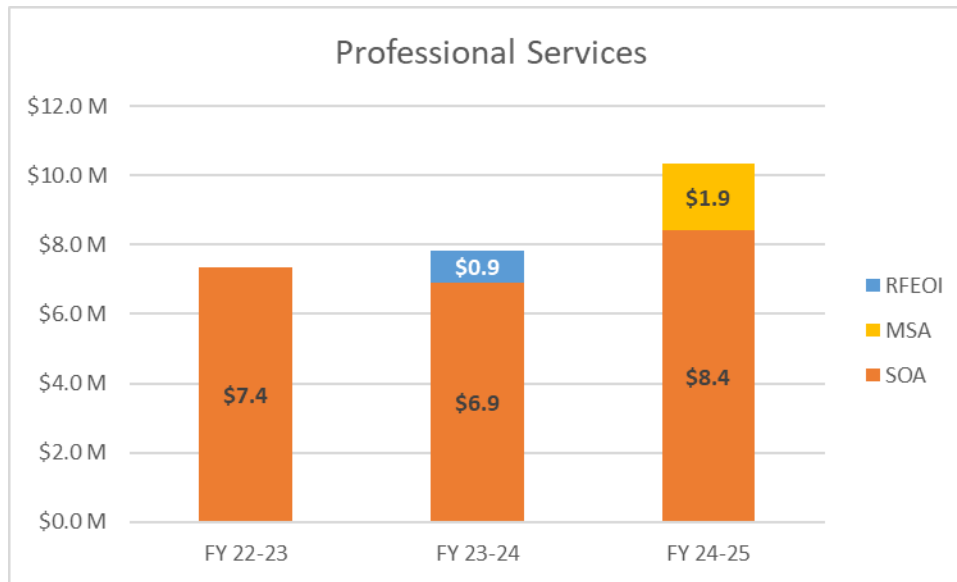


Figure 6 - Professional Services by Procurement Method

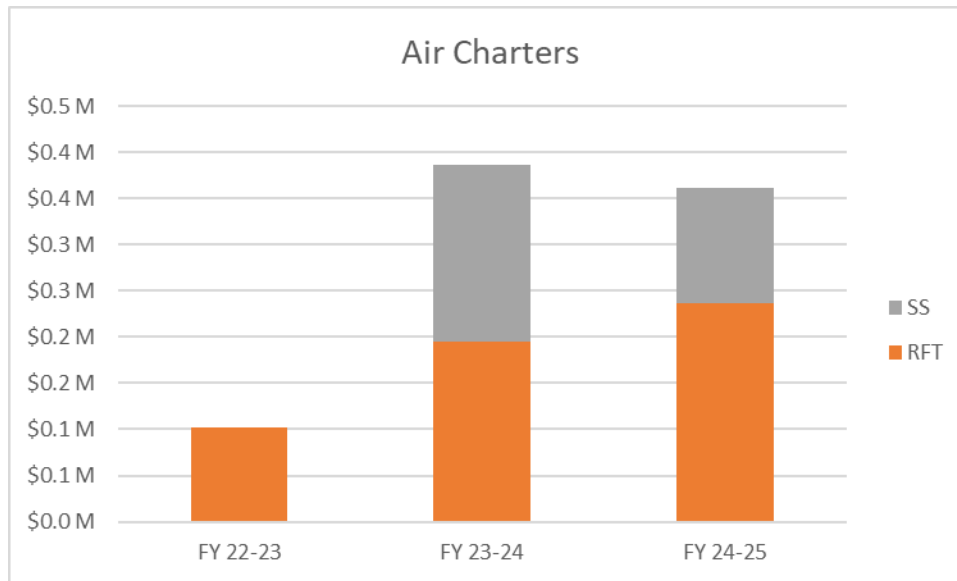


Figure 7 - Air Charters by Procurement Method

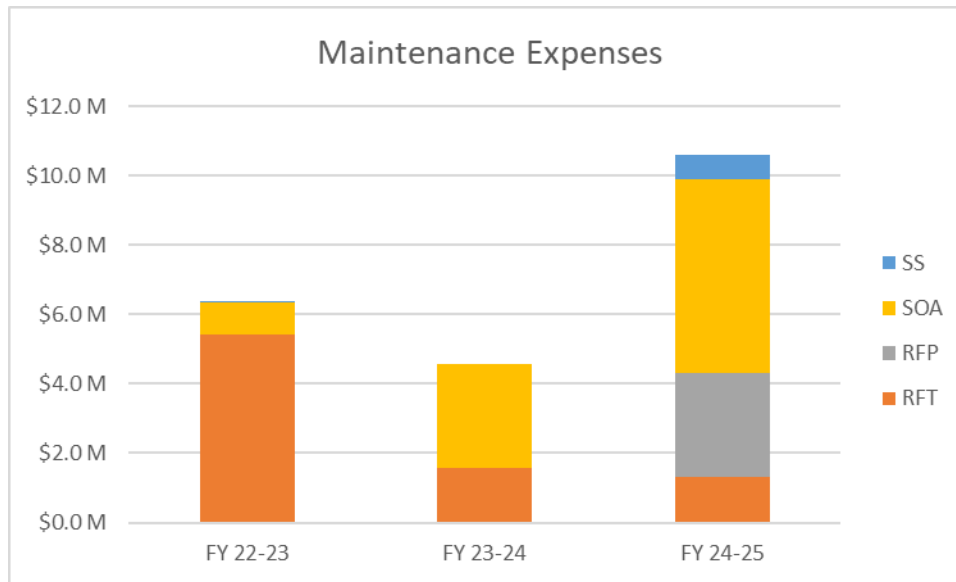


Figure 8 - Maintenance Expenses by Procurement Method

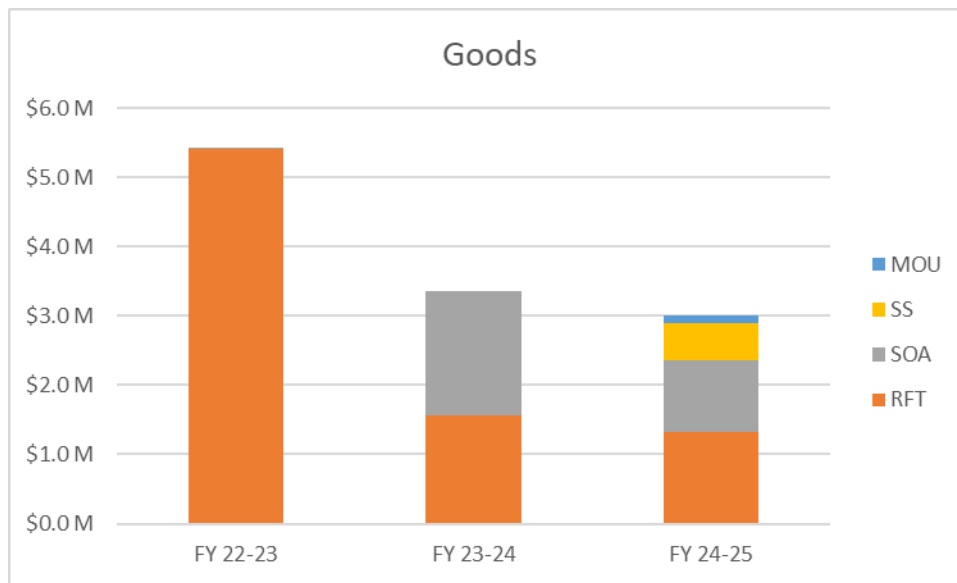


Figure 9 - Goods by Procurement Method

## 2024-25 NHC CAR/PAR/LAR

### Leases

This section provides information on leases held by the NHC used for public and staff housing.

In 2024-2025, new leases were primarily procured through Public Request for Proposals (PRFP). Where possible, NHC opted to renew most leases under the same vendors, as the units were already occupied by NHC public housing or staff housing tenants. Failing to renew the leases would cause significant disruption to operations.

Leases acquired through Memoranda of Understanding (MOUs) are in respect of units acquired on behalf of departments of the Government of Nunavut. All new and all renewed leases are for a period between one and five years.

### Sole Sourcing

Sole Source contracting practices are monitored closely. NHC believes it can get the best value for money through competitive bidding processes. However, there are limited instances where the GN's contracting procedures permit awarding contracts without competition. Listed below are the acceptable conditions for awarding contracts without competition:

1. The goods, services or construction are urgently required, and delay would be harmful to the public interest.
2. Only one party is available and capable of performing the contract.
3. The contract is an architectural or engineering contract that will not exceed \$25,000 in value or is any other type of contract that will not exceed \$5,000 in value.

Any individual category could potentially have sole-sourced contracts. The total amount of sole-sourced contracts for NHC in FY 24-25 amounted to approx. \$2.56 million. All sole-sourced contracts noted in the detailed table contained within Appendix A.

**Goods:** Most Sole Source contracts are for specialized software and computer services.

**Leases:** There are instances when NHC must enter into lease agreements via sole source due to the shortage of available rental units.

**Services:** The increase in service contracts comes primarily from NHC's subscription to an online training platform for staff development.

**Maintenance:** Most Sole Source contracts were for community emergencies or specialized services.
